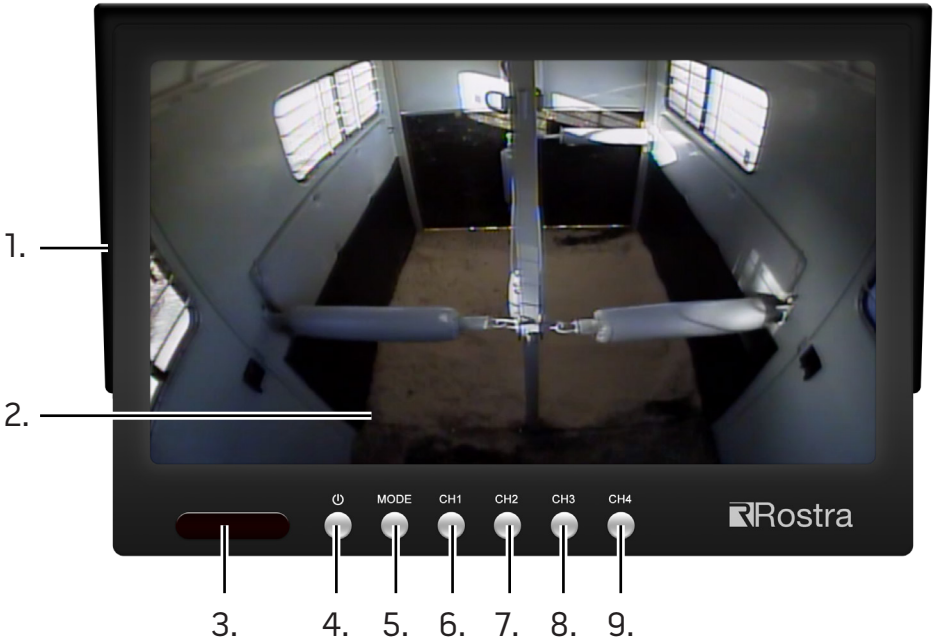



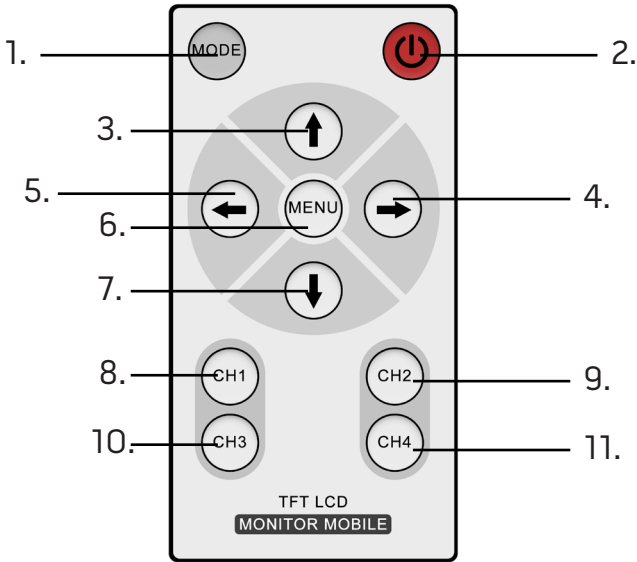


1. Sun Shade

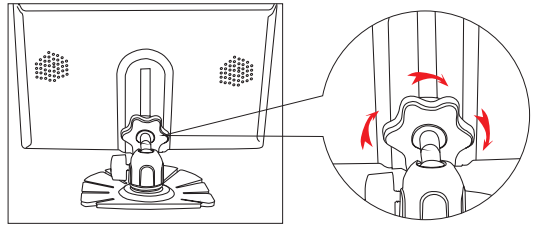
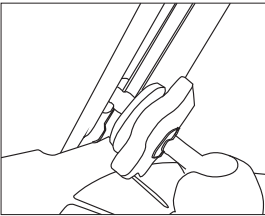


Installation

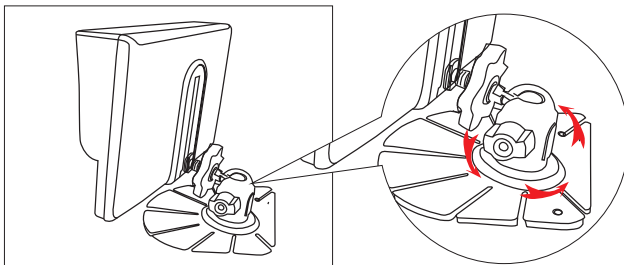
1. The mounting bracket can be secured using the 2 sided tape, screws or both. It is recommended to screw the bracket to the mounting location to ensure the monitor will not become loose in an accident. Use screws to install the bracket tightly to the mounting location. Loosen the mounting screw on the top of the bracket and insert the mounting nut into the channel on the rear of the monitor. (See below pictures)



2. Move the bracket to the proper location and tighten the mounting screw to set the monitor to the proper height. (See below pictures)



3. The monitor position can be adjusted by loosening the screw on the lower part of the bracket. Once the desired position is achieved, tighten the screw to secure the monitor into position. (See below pictures)
